RISK DISCLAIMER AND PRIVACY CONSENT

1. I, for myself, my heirs, next of kin, successors, executors, administrators and assigns:
 - (a) acknowledge that I travel and participate in any tramp or other event organised by the Auckland Baptist Tramping Club Incorporated ("the Club") entirely at my own risk; and
 - (b) hereby waive, release, forever discharge and agree to indemnify the Club, its office-bearers, tramp leaders, event organisers, members, officials, sponsors, promoters, committees, agents, representatives, employees, servants, associations, bodies, suppliers, independent contractors and any other person or organisation involved, engaged in or otherwise associated with any tramp or other event organised by the Club [including (as applicable) his/her/their/its heirs, next of kin, successors, executors, administrators and assigns], from, against and for all liabilities, claims, actions, demands, damages, legal costs or otherwise which I may have against all or any of them arising out of or in any way connected with any such tramp or event, whether such claims are caused by negligence, error of judgment, nuisance, the action or inaction of all or any of them or otherwise howsoever.
2. I hereby attest and verify that I am or will be sufficiently physically and mentally fit, and have appropriate clothing and equipment for any tramp or other event of the Club that I participate in.
3. I agree to follow the reasonable instructions and directions of tramp leaders and event organisers and comply with the rules of the Club.
4. I agree that if a tramp or other event is cancelled by the Club, or if I pull out of a tramp or event, then certain non-refundable costs incurred by the Club may still be payable.
5. I consent to the collection of the above information by the Club. I acknowledge that I am aware that such information is required by the Club for administration, medical, newsletter, trip planning/research and promotional purposes and that I have the right of access to and correction of such information. I consent to the information being retained and used by the Club for such purposes and, without limiting such use, to disclose such information to other Club members, FMC, medical personnel, publications (including Club newsletters and trip reports) and promotional agencies as may be necessary or appropriate.
